Cllr Farr proposed, seconded by Cllr Adams and the Council **resolved** no objection to the application but considers a better design may be more appropriate in order to reduce the visual confusion at the rear of the cottage.

12/19 HIGHWAYS AND PUBLIC RIGHTS OF WAY

The Clerk had written to Penny Hodgson from CORMAC requesting a new footpath sign at Lambourne.

Cllr Giles had received one quote so far regarding the painting of the fingerposts.

Cllr Giles reported a pothole at Praise Hill on the Philleigh King Harry Road and a pothole on the Ruan side of Barn Farm. Cllr Pring stated that the leat on the road to Tregony by Porters was blocked due to the arisings from the cuttings of the hedges. Cllr German would report all issues.

It was considered that the brutal hedge trimming arose from the Trewarthenick Estate.

Cllr Giles proposed, seconded by Cllr Pring and the Council **resolved** that the Clerk write to Trewarthenick Estate asking them to clear the leat.

### 14/19 READING ROOM

The Clerk reported that Awards for All appeared to be a possibility.

Cllr Giles proposed and Cllr Adams seconded and the Council **resolved** that the Council contract Steve Cawse as per his quote to damp proof the rear wall of the Reading Room and advice regarding the other walls which appear to be seeping salts.

Cllr Martin proposed and Cllr Giles seconded and the Council **resolved** that the Cllr Pring contract Mr Prynn to carry out electrical works to improve lighting.

### 15/19 FLOOD FORUM

The Clerk reported that individuals can join the Cornwall Community Flood Forum (CCFF) as full members. Community organisations or associations who have an interest in flooding throughout Cornwall or the Isles of Scilly are welcome and eligible for Associate Membership. They can be either voluntary or statutory and includes Parish and Town Councils. Any individual who wishes to establish a less formal relationship with the CCFF CIO may also become an Associate Member.

Membership to the Cornwall Community Flood Forum is free.

Cllr Martin proposed and Cllr Giles seconded and the Council **resolved** that the Council join the Flood Forum.
