**85/19 APOLOGIES**

Cllr Dingle submitted his apologies due to illness.

Cllr Farr proposed, seconded by Cllr Pring and the Council **resolved** to accept his apologies.

John Adams wrote to the Clerk expressing his interest to join the Council.

Cllr Pring proposed, seconded by Cllr Farr and the Council **resolved** to co-opt John Adams onto the Council.

**88/19 OPEN FORUM – PUBLIC PARTICIPATION**

Philip Martin spoke as a correspondent of the Catherine Celeste Hyde Trust. The quay and associated land were given to parishioners in 1919. He stated that 30-35 years ago, the quay was buried under the saltings and the village at that time suffered from flooding. He stated that parishioners raised money to widen the river and subsequently remove the mud from the quay. As part of the millennium celebrations, money was raised including grant money to surface the quay with granite setts.

He stated that there is approximately £200.00 for the 'Ruan River fund'.

He stated that the quay was constructed by vertical timbers and heavy stones and thought that the quay hasn't deteriorated over 25 to 30 years.

#### 94/19 HIGHWAYS AND PUBLIC RIGHTS OF WAY

Cllr Farr reported that the Library van could not pass by the Kings Head and that there are often difficulties with parked cars. Councillors discussed the problem but no resolution was made.

#### 95/19 QUARTERLY ASSET CHECKS

Cllr Pring reported that all of the assets in Ruan Laniorne village appeared to be in good order.

Cllr Farr reported that the bus shelter has been painted inside but is still awaiting the guttering. The telephone box is starting to look a little tatty but is ok for now.

Cllr Pring reported that Steve Cawrse was going to commence work on Tuesday 2<sup>nd</sup> July. The Clerk highlighted that the Council had asked him to look at additional walls and that further work may be appropriate.

Cllr Farr proposed, seconded by Cllr Martin and the Council **resolved** that Cllr Pring be delegated authority to approve any additional works by Steve Cawrse in the course of his work up to a value of £1000.00.

#### 96/19 RUAN QUAY

Councillors discussed the situation with the quay and felt that clarity was needed regarding the extent of highway responsibility.

Given the centenary of the gift of the land, Cllr Martin wished to refresh the inscribed stone dated 1919.

Cllr Martin proposed, seconded by Cllr J Adams and the Council **resolved** that Caroline Martin investigate restoration of the inscribed stone.

#### 97/19 RUAN POND

It had been reported that children had been in a rubber digby in the pond where a moorhen had been nesting.

Cllr Pring would look at the pond and assess any appropriate signing needs.

#### 98/19 FLY TIPPING

Cllr Martin wanted to commend CORMAC's quick response to clearing some fly-tipping but stated that further items have been fly-tipped and wanted Councillors to be vigilant.
