151/22 THE NATIONAL LOTTERY COMMUNITY FUND – to formally approve conditions of application and formal authorisation of Clerk to submit an application for grant funding for the Ruan Reading Room disabled access

The Clerk noted that he believed authority had been vested to him to make grant applications on behalf of the Council. Councillors agreed. The Clerk reported that he had researched potential grant funding streams for the Ruan Reading Room disabled access project. Formal applications have been made to the Bruce Wake Charitable Trust and the National Lottery Community Fund both of which are likely to be considered in February.

The Clerk noted that the National Lottery Community Fund application included confirmation that consent had been given to apply for the grant and to agree to the terms and conditions. The terms and conditions were circulated to Councillors prior to the meeting. As such, the Clerk requested that formal acceptance of both the making and acceptance of the terms and conditions be formally accepted for completeness.

Cllr Farr proposed, seconded by Cllr Paull and the Council **resolved** to approve consent, agree to the terms and conditions and note the grant application to the Bruce Wake Charitable Trust.
